Acknowledgement and Assumption of Risk and Release

1. The undersigned, as Parents/Guardians of the above referenced Student, hereby acknowledge and agree that:
 - 1.1 Parents/Guardians are desirous of having Student participate in the above described field trip sponsored by Mission Heights Preparatory High School and have granted permission for Student to participate in the trip.
 - 1.2 Parent/Guardians, individually and on behalf of Student, understand that student will be required at all times to follow all written and verbal rules and instructions, including those related to safety, which are presented by Trip Sponsor or any of the Third Party Service Providers (as defined below)
 - 1.3 Student has no injury, illness or other medical condition that would prevent Student from participating in Trip activities or that would make it unreasonably dangerous, harmful, or inadvisable for Student to attend the Trip.
 - 1.4 Parents/Guardians hereby consent to any required emergency medical treatment for Student in the event such care is needed.
 - 1.5 The Trip Sponsor (and it's employees, managers, directors, subsidiaries, affiliates, officers, successors, agents, and assigns, each of whom is included within the term "Trip Sponsor"), will not provide, and is not affiliated, in any way, with any of the entities or persons which may provide goods or services relative to the trip including, but not limited to transportation services and food service providers.
 - 1.6 Parents/Guardians, individually and on behalf of the Student, have voluntarily accepted the opportunity to have Student take part in the Trip and have done so with the full knowledge of the risks associated with the Trip, including but not limited to those risks inherent in transportation, food and other services associated with the Trip. As a result, Trip Sponsor shall not be liable for any negligent or willful act or failure to act of any Third Party Service Provider or of any other Third Party whatsoever.

1.7 Parent/Guardians, Individually and on behalf of the Student, understand that participation in the Trip could involve risk of physical injury, illness, death or property loss, and despite the implementation of appropriate safety precautions and the presence of reasonable adult supervision, Trip Sponsor cannot guarantee that as all risks cannot be prevented and Trip Sponsor does not provide health and accident insurance for trip participants and therefore any medical expenses, property loss, or other personal expenditures that result during or from trip are to be borne by the Student, or by the undersigned as Student's parent or guardian.

1.8 Parents/Guardians and Student understand that Student's ability to participate in the Trip and each of the elements associated therewith, is contingent upon the execution of this Acknowledgement and Assumption of Risk and Release form.

Therefore, as lawful consideration for Student being permitted to participate in the Trip, the undersigned, individually and on behalf of Student, hereby RELEASE AND DISCHARGE FOREVER TRIP SPONSOR FROM AND AGAINST ANY AND ALL LIABILITY ARISING FROM PARTICIPANT'S PARTICIPATION IN THE TRIP. The undersigned agree that this release shall be legally binding upon them personally, the Student and all members of their family, their heirs, successors, assigns, and legal representatives, it being the undersigned's intention to fully assume all the risks associated with this Trip and to release Trip Sponsors from any and all liabilities to the maximum extent permitted by law.
3. The undersigned, individually and on behalf of Student, agree that any dispute concerning, relating, or referring to the Trip shall be resolved exclusively by binding arbitration according to the then existing rules of the American Arbitration Association in Phoenix, Arizona. Such proceedings will be governed by substantive Arizona law.
